

AGREEMENT NO. 2019-159B

SECOND AMENDMENT TO MAINTENANCE CONTRACT

This Second Amendment to maintenance Contract Agreement No. 2019-159 ("Amendment") effective date of April 14, 2021, is entered into between the City of Camarillo, a California general law city and municipal corporation (City), and Landscape Development Inc., dba Enhanced Landscape Management, a California corporation ("Contractor") collectively referred to as the Parties.

RECITALS

A. The Parties have entered into a written agreement entitled "Maintenance Contract Agreement Number 2019-159" having an effective date of January 1, 2020, ("Agreement") to provide for certain maintenance services in the amount of \$6,336,708 as outlined in Exhibit A of Agreement from Contractor.

B. The term of the Agreement is forty-two months ending June 30, 2023. The Agreement includes provisions for two, one-year extensions.

C. On July 22, 2020, City Council received and approved a request to amend the Contract ("First Amendment"). The First Amendment included a reduction in the scope of landscape maintenance services and frequencies due to economic impacts of the COVID-19 pandemic on City general fund revenues. The reduced scope of landscape maintenance services and frequencies resulted in a decreased Agreement amount of \$1,471,339.80 for FY 2020/21, and a total authorized Agreement amount of \$5,498,179.40.

D. All capitalized terms not defined in this Amendment have the meaning set forth in the Agreement.

E. The parties desire to modify the Scope of Work in accordance with Section 16.5 of the Agreement.

Section 1. Amendment. The Agreement is amended as follows:

Contractor to perform special projects and landscape renovations in several assessment districts that will include removing and replacing old landscaping material, filling in bare spots and upgrading the irrigation system within the areas where new plant material will be installed in an amount of \$16,275 per attached Exhibit A, and perform any necessary additional irrigation system modifications in the course of the landscaping upgrades in an amount not-to-exceed \$10,725 for a total amendment amount of \$27,000.

Section 2. Compensation and Payment. This Second Amendment to the Maintenance Contract is for a not-to-exceed amount of \$27,000 for Fiscal Year 2020/21 for a total agreement amount not-to-exceed \$5,525,179.40.

Section 3. Continuation of Terms of Agreement. Except as expressly modified by the terms and provisions of this document, the remaining terms and provisions of the Agreement remain in full force and effect.

THE AUTHORIZED REPRESENTATIVES of the Parties have caused this
Amendment, Agreement No. 2019-159B, to be executed as of the Effective Date above.
