

**RESOLUTION NO. 2024-**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CAMARILLO,  
CALIFORNIA, CALLING AND GIVING NOTICE OF THE GENERAL  
MUNICIPAL ELECTION TO BE HELD TUESDAY, NOVEMBER 5, 2024, FOR  
THE ELECTION OF CERTAIN OFFICERS AS REQUIRED BY THE  
PROVISIONS OF THE LAWS OF THE STATE OF CALIFORNIA RELATING  
TO GENERAL LAW CITIES**

The City Council of the City of Camarillo resolves as follows:

**SECTION 1:** Pursuant to the requirements of the laws of the State of California relating to general law cities, there is called and ordered to be held in the City of Camarillo, California, on Tuesday, November 5, 2024, a General Municipal Election for the purpose of electing one City Councilmember to District 3 and one City Councilmember to District 4, both for the full term of four years.

**SECTION 2:** The ballots used at the election shall be in form and content as required by law.

**SECTION 3:** The City Clerk is authorized, instructed and directed to coordinate with the Ventura County Elections Division to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment and paraphernalia that may be necessary in order to properly and lawfully conduct the election.

**SECTION 4:** The polls for the election shall open at 7:00 a.m. on the day of the election and remain open continuously from that time until 8:00 p.m. of the same day when the polls shall close pursuant to Elections Code Section 10242, except as provided in Section 14401 of the Elections Code.

**SECTION 5:** In all particulars not recited in this Resolution, the election shall be held and conducted as provided by law for holding municipal elections.

**SECTION 6:** Notice of the time and place of holding the election is given and the City Clerk is authorized, instructed, and directed to give further or additional notice of the election, in time, form and manner as required by law.

**SECTION 7:** In the event of a tie vote, the City Council authorizes the Ventura County Clerk to resolve the tie vote as set forth in Elections Code Section 15651(a).

**SECTION 8:** The City Clerk is authorized to administer the election and all reasonable and actual election expenses shall be paid by the City upon presentation of an invoice submitted by the Ventura County Elections Division.
