

## AGREEMENT NO. 2022-139A

### FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This First Amendment to Agreement No. 2022-139 (Amendment) is entered into between the City of Camarillo, a California general law city and municipal corporation (City), and CV Enterprises, Inc. dba CompuVision, collectively referred to as the Parties. The effective date of this First Amendment is 7/1/2025.

#### **RECITALS**

A. On May 11, 2022, the City Council approved Professional Services Agreement No. 2022-139 with CV Enterprises, Inc. dba CompuVision for offsite data backup solution and services in the amount of \$87,915.27 for three-years, effective July 1, 2022 (Agreement).

B. CompuVision provides offsite backup solutions and data monitoring services.

C. The parties have agreed on a modified Scope of Services (Exhibit A), pricing, and desire to extend the agreement for an additional three-year period as allowed for in Section 3.3 of the Agreement.

D. All capitalized terms not defined in this Amendment have the meaning set forth in the Agreement.

**Section 1. Amendment.** The Agreement is amended to add the following:

a. Section 1. Term of Agreement is amended to read as follows: Term is extended for three-years; July 1, 2025 to June 30, 2028.

b. Section 2. Scope and Performance of Services is amended per Exhibit A, for the extended three-year term, including services and pricing.

**Section 2. Compensation and Payment.** This Amendment is for a not-to-exceed amount of \$99,751.64, for a total agreement amount of \$187,666.91.

**Section 3. Continuation of Terms of Agreement.** Except as expressly modified by the terms and provisions of this document, the remaining terms and provisions of the Agreement remain in full force and effect.

THE AUTHORIZED REPRESENTATIVES of the Parties have caused this Amendment, Agreement No. 2022-139A, to be executed as of the Effective Date.
