

FIRST AMENDMENT TO AGREEMENT FOR GENERAL SERVICES UNIFORM RENTAL AND FULL GARMENT AND SUPPLY SERVICES

This First Amendment to CC/CSD Agreement No. 2022-213 is entered into between the CITY OF CAMARILLO, a California municipal corporation and general law city ("City"), and CAMARILLO SANITARY DISTRICT, a Sanitary District organized pursuant to the California Health and Safety Code ("District"), and PRUDENTIAL OVERALL SUPPLY, a California corporation ("Contractor"), collectively referred to as the "Parties." The effective date of this Amendment is June 11, 2025.

RECITALS

On December 14, 2022, the City Council and District Board approved an Agreement with Contractor in the amount of \$28,350 for Uniform Rental and Full Garment and Supply Services. The Parties entered into a written agreement entitled Agreement for General Services, CC/CSD Agreement No. 2022-213 effective December 14, 2022 (Agreement).

A. All capitalized terms not defined in this Amendment have the meaning set forth in the Agreement.

B. The parties desire to modify the term in accordance with Section 7.2 of the Agreement.

Section 1. Amendment. The Agreement is hereby amended as follows:

- A. Effective November 1, 2024, the rates set forth in Exhibit B of the Agreement are replaced with the updated rates shown in Exhibit A, attached hereto and incorporated by reference.
- B. Exhibit B, Item 6, is deleted in its entirety and replaced with the following:

The Contractor may request an annual adjustment to compensation based on the Consumer Price Index for All Urban Consumers (CPI-U) for the Los Angeles Region, measured from September of the prior year to September of the current year. Requests must be submitted to both the Water Reclamation Superintendent and the Fleet and Facilities Manager by November 1st of the current year.

Section 2. Compensation and Payment. This Amendment is for a not to exceed amount of \$26,250 for a total agreement amount of \$56,400.

Section 3. Continuation of Terms of Agreement. Except as expressly modified by the terms and provisions of this document, the remaining terms and provisions of the Agreement remain in full force and effect.

THE AUTHORIZED REPRESENTATIVES of the Parties have caused this First Amendment, CC/CSD Agreement No. 2022-213A, as of the Effective Date of June 11, 2025.
