TAKE NOTICE, that the City of Camarillo City Council will conduct a public hearing on **Wednesday, August 14, 2024**, at 5:00 p.m., or soon thereafter, in the Camarillo Library Community Room, 4101 Las Posas Road, Camarillo, on the following agenda item:

### **Zoning Ordinance Amendment Regarding Pet Cemeteries**

The City is considering a proposal from Ivy Lawn Memorial Park & Funeral Home for a Zoning Ordinance Amendment (ZOA) to amend the Camarillo Municipal Code (CMC) to allow pet cemeteries in the Professional Office (P-O) Zone.

The proposed ZOA is exempt from the provisions of the California Environmental Quality Act (CEQA) under the State CEQA Guidelines Sections 15060(c)(2) and 15378.

Any person interested in this matter is invited to attend and provide comments on the proposed action. If you challenge the proposed action in court, you may be limited to raising only those issues raised at the meeting verbally or in writing.
